Documents (Scanned colour copies) to be submitted by the Applicants to Regional Centre by mail and another set of documents through Post (self attested copies)

(1) By All Applicants:

- Original Admit card of Entrance Test Hall Ticket duly signed by the invigilator. Photocopy of the same will not be accepted.
- 10th class marks card / Pass certificate
- 10+2/PUC pass certificate
- Diploma Certificate of GNM (Including mark sheets of all years)
- Valid RNRN Registration Certificate (In case of registration from more than one council, produce all registrations)
- In lieu of mid-wifery, the male nurses produce the certificate in any nursing course of 6-9 months duration as recognized by Indian Nursing Council. The candidates should produce relevant documents authenticating that such nursing course is recognized and approved by the Indian Nursing Council.
- Two recent coloured Passport size photographs

Present Employment:

Experience Certificate/s - On Letter Head of the competent authority with full name, date and signature with stamp. Experience will be counted after RNRN registration till the last date of receipt of application. Carry the originals for verification.

- Original Anti ragging Affidavits in the prescribed formats duly Notarized and signed by Parents and Applicant separately. (Refer page 109 & 110 of the Post Basic B.Sc Nursing Student Handbook & Prospectus – 2021)

(2) Documents to be submitted by applicants claiming reserved seat:

- (i) **Category/Social Status:** Candidates belonging to reserved category must enclose duly attested (by the **Gazette Officer**) Photocopies of the latest Category Certificate, valid as on 1st Jan. 2021 (SC/ST/PH/EWS/OBC Non- Creamy Layer/Social Status WWKM). If the relevant documents, duly attested, are not submitted, your acceptance form will not be entertained. Carry the originals for verification. For OBC category students, **SEATS WILL BE ALLOTTED ONLY IF YOUR CASTE IS MENTIONED IN THE NATIONAL COMMISSION FOR BACKWARD CLASSES OF GOVERNMENT OF INDIA. PLEASE PROVIDE THE SERIAL NUMBER OF YOUR CASTE MENTIONED IN THE CENTRAL LIST OF OBCNC WHICH CAN BE VERIFIED IN the website:**http://www.ncbc.nic.in/User_Panel/CasteSearchingView.aspx
- (ii) The applicants who have mentioned A1, B2, C3, D4A or D4 in the “Category” box of PB-BSCN Entrance Test form will not be considered under OBC (Non-Creamy Layer).
- (iii) The OBC applicants, who have not submitted NON-CREAMY certificate or Income Certificate or opted for D4A or D4 category will be treated as Creamy OBC or General Category students.
- (iv) The candidates claiming EWS (Economically Weaker Section) reservation should produce the Certificate issued by an officer not below the rank of Tahsildar in the State / UT. The officer issuing the certificate would do the same after carefully verifying all relevant documents following the due process as prescribed by the respective State / UT.
- (v) **NO CHANGE OF DECLARED CATEGORY WILL BE ENTERTAINED AT ANY POINT OF TIME**
